

Bernanke Saves Bear Stearns While Americans Live In Tents

WASHINGTON, D.C. — After bailing out America's broke banks to the tune of \$200 billion, the Federal Reserve turned their philanthropic eye to Bear Stearns, and they're not even a bank!
